Re: Immunization Record Information

Immunization is one of the most successful strategies to prevent illness related to vaccine-preventable diseases. The *Ontario Day Nurseries Act, R.R.O. 1990* requires all children attending a licensed child care centre to be fully immunized.

York Region Community and Health Services (YRCHS) is required to keep up-to-date immunization records for every child attending a licensed child care centre in York Region.

Beginning this year, YRCHS will be working with all licensed child care centre operators in the Region to collect demographic and immunization information for all children that attend each child care centre. Each child's record will be reviewed to ensure that they have received immunizations appropriate for his/her age.

We will contact you if your child's immunization information is incomplete according to the information that has been provided by the child care operators.

If you decide not to immunize your child due to medical, conscience or religious reasons, the forms are available online at www.york.ca/immunization. These forms must be completed and returned to us.

All information requested and received will remain confidential.
